# **The Interview**

Ian Barlow is a security risk management consultant with specialist knowledge of fraud investigations gained during a career in the Commercial Crime Bureau of the Hong Kong Police, and working in Asia as a risk manager in the financial services and advanced technology industries. He is a Certified Fraud Examiner and board member of the Hong Kong Chapter of the Association of Certified Fraud Examiners, an ISACA Certified Information Security Manager, ASIS Certified Protection Professional, and a member of the Business Continuity Institute. He now works as an independent security risk management consultant.

#### **Outline:**

Fraud examiners, accountants, auditors and forensic specialists are experts in gathering evidence from documents and computer file examination. Following the trail of breadcrumbs builds cases and gathers the facts that will identify lost assets and those responsible for the loss. But documents, bits and bytes aren't the end of the story. To bring a successful investigation to the point where disciplinary action, civil litigation or criminal prosecution can be considered, there is one final essential step. The interview. Considering the right approach and interview format are no less important than gathering that documentary and computer evidence. There will always be a need to examine items with the help of someone who has specialist knowledge of the evidence, or to talk to the person most likely to have been responsible for the loss. There is no "one-size-fits-all" method that suits both the innocent witness and the knowing fraudster. In this session we will examine some different interviewing approaches, the tools available to the fraud examiner, and offer a methodology that can be adapted to the different circumstances fraud examination presents.

**Desmond Yu** is a partner at MinterEllison LLP's financial services regulatory practice group. Desmond has over 25 years of extensive experience in regulatory matters and complex commercial litigation, with a focus on contentious financial services and regulatory matters, including compliance and governance matters, statutory/confidential investigations, disciplinary proceedings and statutory public inquiries, and financial services and securities related criminal matters. Desmond represents a wide spectrum of clients, including international conglomerates, state-owned enterprises, publicly listed companies, financial institutions and fund managers, high net-worth individuals, and participants of all levels in the financial industry. Desmond is experienced in matters involving financial regulators (such as The Stock Exchange of Hong Kong Limited), statutory bodies (such as the Hong Kong Monetary Authority, Securities and Futures Commission, and Accounting and Financial Reporting Council) and other law enforcement agencies (such as the Commercial Crime Bureau (CCB) of the Hong Kong Police and the Independent Commission Against Corruption).

**Desmond Liaw** specialises in complex commercial and civil litigation, with emphasis on areas such as corporaterelated disputes, contractual disputes, financial services-related disputes, employment, fraud, trust and professional negligence, with more than 24 years of experience. He has assisted clients on numerous 'email fraud' cases, and many of his cases involve asset recovery. He co-leads MinterEllison's employment practice group, and his other area of speciality is in insolvency and bankruptcy. Apart from these areas of speciality, Desmond is also experienced in Securities Futures Commission matters, regularly advising licensed corporations and individuals in investigations by the regulator. He conducts internal investigations into potential regulatory breaches by clients (typically companies), as well as previously, investigations involving the U.S. Foreign Corrupt Practices Act (FCPA). He also represents clients in investigations and prosecutions by the Hong Kong Independent Commission Against Corruption (ICAC) and the Commercial Crime Bureau (CCB) of the Hong Kong Police.

**Jun Kwong** is a Partner of MinterEllison LLP's financial services regulatory practice group. He has over 10 years of experience in advising institutional and individual clients in investigations and/or proceedings commenced by various regulatory authorities and law enforcement agencies in Hong Kong, including the Securities and Futures Commission, The Stock Exchange of Hong Kong Limited, the Independent Commission Against Corruption and the Financial Intelligence and Investigation Bureau of the Hong Kong Police Force. Jun has handled a number of corporate investigations conducted by listed companies in respect of corporate misconduct, accounting irregularities and corporate governance etc, and has advised clients in related regulatory investigations.

## **Outline:**

In recent years, many Hong Kong listed companies suffer from prolonged suspension of trading of shares, which may be may be due to various regulatory and compliance issues, including suspected accounting irregularity and corporate misfeasance. In seeking to resume trading, the Hong Kong Stock Exchange may impose conditions, one of which would require a listed company to conduct independent internal investigations to address such issues. As part of the listed company's efforts to seek a resumption, it is crucial for management of listed companies to structure and complete the necessary independent investigations.

This seminar will cover the latest trends of Hong Kong listed company internal investigations, and MinterEllison's insights on the key points to note from a legal and regulatory perspective.

Separately, speakers will discuss the all too common 'email fraud' cases, which continue to be considerable despite much publication about it. Speakers will talk about the practical steps to take vis-à-vis the police and the banks, as well as how such cases are pursued through the courts.

# The War Against Corruption

# Presenter: Gilbert T.S. Chan, Former Director of ICAC Operations Department and Managing Director & Senior Counsel of Goldman Sachs Asia LLC

Gilbert's 28-year career with the ICAC culminated in the position of Director of ICAC Operations Department and appointment as member of INTERPOL's International Group of Experts on Corruption. In this role, Gilbert managed many high-profile investigations and prosecutions. At Goldman Sachs Asia LLC Gilbert oversaw for 15 years the bank's Anti-Bribery & Anti-Money Laundering Programs and its response to law enforcement & regulatory enquiries. Gilbert offers unrivalled expertise in understanding the motivations & vulnerabilities for corruption and the methods of investigating and preventing corruption and its close relatives fraud & money laundering.

## **Outline:**

Gilbert will draw on both the prosecutorial and defence sides of his 43-year career experience to offer practitioner's perspectives on corruption investigation and prevention, based on his criminal law enforcement experience with the ICAC and inhouse regulatory lawyer experience with a global investment bank. Gilbert will examine the societal landscape leading to the establishment of the Independent Commission Against Corruption in Hong Kong in 1974, and the role of corrupt policeman Peter Godber in spurring the colonial government's determination to fight corruption at all levels. The success of the ICAC in significantly reducing public and private sector corruption has made Hong Kong the envy of many countries worldwide, and has been due in no small part to the major investigations and prosecutions that Gilbert participated in and supervised during his 28 years with the ICAC. In this presentation Gilbert will discuss some of his most significant ICAC cases, examining and highlighting the lessons which are still very relevant today. Gilbert will also speak about fighting corruption from within a regulated private sector financial institution, based on his 15-year tenure at the Wall Street investment banking giant Goldman Sachs. He will look at the similarities and highlight the most significant differences between public sector and financial services corruption, both at a Hong Kong and an international level.

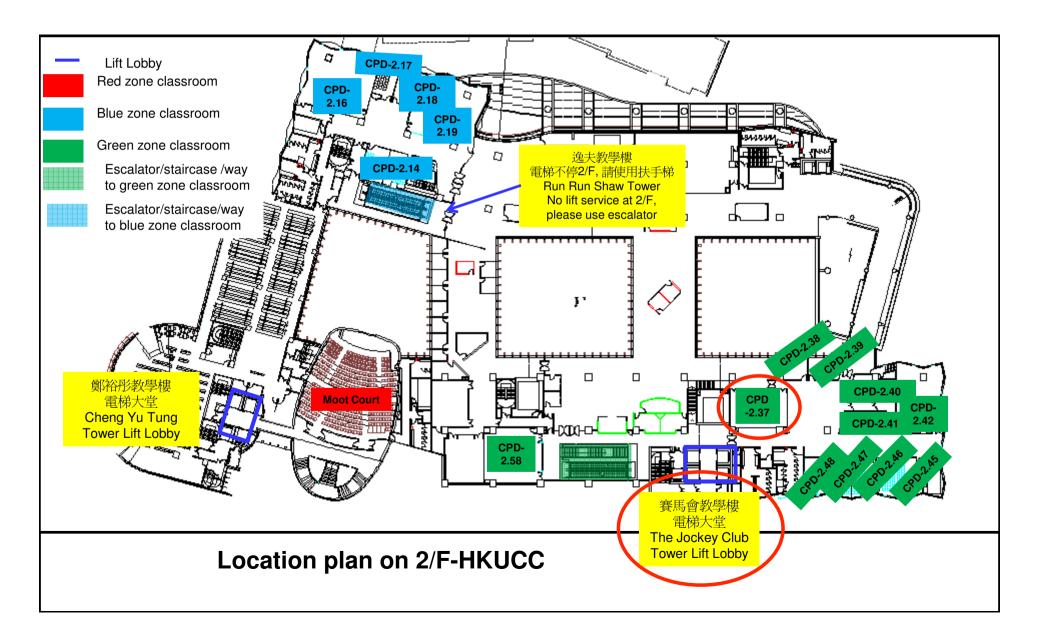

6. Take the lift to 2/F.

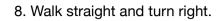




7. Go through the exit door on 2/F at the right hand side of the lift lobby.
